**SUBJECT:** UNIVERSITY OF CALIFORNIA RIVERSIDE MEDICAL SCHOOL RESOLUTION

**RECOMMENDATION:** Adopt resolution supporting the efforts of the University of California Riverside for a School of Medicine.

**BACKGROUND INFORMATION:** The University of California Riverside (UCR) is proposing to build a medical school by 2012, which would be the first to open in California in 40 years. On June 27, 2006, the San Bernardino County Board of Supervisors approved a purchase order, in the amount not to exceed \$100,000, to pay for a share of the cost of a feasibility study to examine issues relating to residents' access to medical care in the future.

The study examined population growth in the region, projected future physician shortfalls, and the lack of specialized physicians. UCR will meet with the Board of Regents on November 14-16, 2006, and the proposed resolution expresses San Bernardino County's strong support for a UCR School of Medicine.
